**SECTION 6. Accidental release measures****6.1. Personal precautions, protective equipment and emergency procedures**

Block the leakage if there is no hazard.

When performing transfer operations involving large containers, connect to an earthing system and wear antistatic footwear. In order to avoid the risk of fires and explosions, never use compressed air when handling. Open containers with caution as they may be pressurised. Do not eat, drink or smoke during use. **8.2. Exposure controls**

As the use of adequate technical equipment must always take priority over personal protective equipment, make sure that the workplace is well aired through effective local aspiration.
